I. Call to Order

The meeting was called to order by the Vice-President at 5:30 P.M.

III. Approval of Agenda

IV. Superintendent's Report

- Pending board approval of new hires, the district is fully staffed.
- Summer projects are progressing well: completed numerous cleaning and small improvement projects, upgraded servers, installed new clocks in the gym, and purchased a new compressor for the walk-in freezer and refrigerator.
- Staff return in two weeks; All Staff Workday on Monday, August 25; Back to School Picnic on Wednesday, August 27.
- A new board member will be appointed this evening due to Jake Zimmer's resignation following the
 last meeting. Appointment must occur by Wednesday, August 13, 2025, or the ISD will appoint. The
 appointed member will serve until November 2026 and may choose to run for the remainder of the
 term. Future vacancies will be better advertised via the district website, with a permanent form for
 interested candidates.
