# VI. Superintendent's Report

- **Federal Budget Implications:** Update on federal spending processes affecting school funding, including concerns around Medicaid, school meals, and special education grants.
- Civics Education Initiatives: Mr. Fryer is interested in pursuing a Civil Discourse Credential through Close-Up and subscribing to "Current Issues" resources to support student civic engagement.
- **Summer Projects:** Include gym audio repairs, clock and signage updates, server replacements, door replacements, and ceiling tile work.
- Transportation: Two aging buses (2011 & 2014) will be sold via sealed bid.
- **LIFT**: The Board expressed full support for the LIFT program, pending legal review and funding mechanisms. Other districts use pass-through grants or service agreements.
